Welcome to the practice application for the Illinois NB Retake Candidate Fee Subsidy. You must be a licensed Illinois teacher or a counselor to qualify for the subsidy.

NOTE: If you received the Illinois NB Retake Candidate Fee Subsidy for any portion of a component in the past, you are not eligible to apply again for that portion unless you withdrew from the portion within the required timeline.
